The New Permanent Observer of the Holy See to the UN, H.E. Archbishop Ivan Jurkovič took office on 1 April 2016. Since his appointment he has participated and chaired several conferences and is directly involved in the strategic planning of the Foundation for the coming years. Throughout the spring and the summer of 2016, the Foundation has organized several conferences and launched different mid and long term projects (mentioned hereafter). H.E. Archbishop Ivan Jurkovič is looking forward to fruitful years ahead, with the hope for continued financial support from institutional and private donors and also to an excellent cooperation with the scientific collaborators who help us to deliver fast and pertinent information and expertise to enhance our work at the UN.

- **Board:** As president of the Foundation, H.E. Archbishop Ivan Jurkovič appointed two new board members: H.E. Albrecht Freiherr von Boeselager *ad interim*, Grand Chancellor of the Order of Malta and Mr. Xavier Rey. The new constellation of the board is as follows: H.E. Archbishop Ivan Jurkovič (President), Mr. Marc Odendall (Treasurer), Mr. Jean Tardieu (Secretary), Mgr. Richard Gyhra (Member), H.E. Albrecht Freiherr von Boeselager (Member *ad interim*), Mr. Xavier Rey (Member). The members of the Board will support and help the Foundation in its future work and fundraising efforts.

ACTIVITIES

Conferences

Throughout the year, the Foundation participates in the organization of several high-level seminars to discuss specific topics of international relevance. In recent months, the President of the Foundation participated in and intervened on the following:

- 105th Session of the International Labor Conference (ILO), in Geneva, May-June 2016;
- 14th Ministerial Conference on Trade and Development (UNCTAD), in Nairobi, July 2016;
- General Assembly of the World Intellectual Property Organization (WIPO), in Geneva, October 2016

In April 2016, the Foundation, together with the Pontifical Council for the Family and Catholic Inspired NGOs Forum Geneva organized the first international presentation of Pope Francis's "Apostolic Exhortation *Amoris Laetitia*" in Rome. More than fifty ambassadors accredited to the Holy See and twenty representatives of NGOs were present during the interventions of H.E. Archbishop Vincenzo Paglia and H.E. Archbishop Ivan Jurkovič.

During the 32nd Session of the Human Rights Council in June 2016, the Foundation and the Mission of the Holy See organized a side-event at the UN on the "Joy of Love: Family as a Vital Force in Society". The conference referred to the family as the most incredible resource of humanity and claimed for its support through concrete policies. Through the family, quality of life improves in terms of values, social and economic development. H.E. Archbishop Vincenzo Paglia, President of the Pontifical Council for the Family gave the key-note speech. Follow the [link](#) to download all the interventions.

The 32nd and 33rd Session of the Human Rights Council (HRC) of the UN took place in June and September 2016, respectively. The Holy See Mission, with the support of expertise provided by the Foundation, intervened on the following topics:

- The Right of Women
- Migrants
- Human Rights and Business
- Cybersecurity
- The Right to Water
- The Right of Older Persons

The next Human Rights Council will take place in March 2017, during which the Holy See Mission and the Foundation will organize a side-event on "Unaccompanied Child Migrants".
